




#### PRESENTATION of CREDENTIALS

PRIOR to High Commissioner Allan Joseph Chintedza's appointment here, he is also concurrently Malawi's Ambassador to China, as well as accredited to Bhutan, Cambodia, the Democratic People's Republic of Korea, Indonesia, Malaysia, Mongolia, Laos, Vietnam, and Thailand. The Ambassador joined the diplomatic service in July 2021. High Commissioner Chintedza was formerly involved in development work, particularly in poverty eradication programmes both in Malawi and abroad. He began his career as a Programme Officer for the United Nations Development Programme in Malawi, and later as the Assistant Resident Representative for

the United Nations Capital Development Fund. He has served in various capacities including Deputy Executive Secretary for PRIDE Africa in Nairobi, Kenya.

High Commissioner Chintedza holds a Masters of Arts in Economics and Social Studies from the University of Manchester, UK, and a Bachelor of Arts in Public Administration from the University of Malawi.

PRIOR to Ambassador Lahcene Kaid Slimane's assignment to Singapore He was appointed Ambassador of the People's Democratic Republic of Algeria to the Republic of Indonesia in 2021, and is concurrently accredited to the Republic of Singapore, Negara Brunei Darussalam and ASEAN.

The Ambassador is a career diplomat. He has been the Ambassador Counsellor in the Cabinet of the Ministry of Foreign Affairs, Director General of Resources, Ambassador to Namibia and General Consul at Strasbourg. Earlier in his career, Ambassador Kaid Slimane has also worked at the Republic's Presidency and Ministry of Foreign Affairs as Director in several departments, including Human Resources, Protocol Affairs, Bilateral relations with Africa and with Southeast Asia-Oceania.

## Summit Commemorates 45 Years of ASEAN-EU Ties

Leaders meet for historic milestone meeting to deepen cooperation and ties between ASEAN and EU



PRIME Minister Lee attended the ASEAN-EU Commemorative Summit on 14th December 2022 in Brussels, Belgium. This is the first ASEAN-EU Summit involving the Leaders of the Member States of ASEAN and of the EU. The Commemorative Summit marks 45 years of ASEAN-EU dialogue relations and was an opportunity for both sides to discuss ways to further deepen ASEAN-EU relations. In Brussels, PM Lee was accompanied by Mrs Lee, Minister for Foreign Affairs Dr Vivian Balakrishnan, as well as officials from the Prime Minister's Office and Ministry of Foreign Affairs.

PM Lee and President of the European Commission Ursula von der Leyen (pictured above) met on the sidelines of the Summit, where they announced the substantial conclusion of a new Digital Partnership between the EU and Singapore. PM Lee also met

and held bilateral meetings with other European Leaders on the sidelines of the Summit.

The historic summit was co-chaired by the President of the European Council, Charles Michel, and the 2022 ASEAN Chair, Cambodian Prime Minister Hun Sen. In his welcome remarks, President Charles Michel said the event was the first ever EU-ASEAN Summit, to be held in Brussels, in the European Council and the home

## Launch of Singapore-Oman Strategic Dialogue

FOREIGN Minister of the Sultanate of Oman, His Excellency Sayyid Badr Bin Hamid Bin Hamood Al Busaidi, and National Security Council Secretary-General of the Sultanate of Oman, Major General (MG) Idris Bin Abdulrahman Bin Hamoud Al Kindi, co-chaired the inaugural Singapore-Oman Strategic Dialogue (SOSD) with Minister for Home Affairs and Minister for Law K Shanmugam and Minister in the Prime Minister's Office, Second Minister for Foreign Affairs and Second Minister for Education, Dr. Mohamad Maliki Osman. Both sides reaffirmed the warm and longstanding relations between Singapore and Oman.

The co-chairs had a wide-ranging discussion to strengthen cooperation in various sectors

including trade and investment, renewable energy, aquaculture, transport and logistics, and communications and information technology in support of Oman's Vision 2040. They also discussed opportunities to deepen cooperation in areas such as capacity-building, counterterrorism, and maritime security; as well as exchanged views on developments in the Middle East and Asia.

To bring ties to a new level, Singapore and Oman have agreed to concurrently upgrade our respective Consulates-General to Embassies headed by a Chargé d'Affaires. Singapore and Oman will implement the upgrade on a mutually agreed date to be announced.

## State Visit: José Ramos-Horta, President of Timor-Leste

H.E. José Ramos-Horta, President of the Democratic Republic of Timor-Leste, made a State Visit to Singapore from 6 to 11 December 2022 at the invitation of President Halimah Yacob. This was the first State Visit from Timor-Leste and marks the 20th anniversary of the establishment of diplomatic relations between Singapore and Timor-Leste.

President Ramos-Horta attended an official Welcome Ceremony held in his honour at the Istana on 8 December 2022. He met President Halimah Yacob and Prime Minister Lee Hsien Loong, who hosted a State Banquet and an official lunch respectively. President Ramos-Horta had an orchid named in his honour, delivered the 45th Singapore Lecture organized by the ISEAS - Yusof Ishak Institute and visited the NEWater Visitor Centre.

President Ramos-Horta was accompanied by Minister for Foreign Affairs and Cooperation Adaljiza Magno, Coordinating Minister for Economic Affairs Joaquim Amaral, members of parliament, and senior officials.

During the visit, PM Lee hosted President Ramos-Horta to an official lunch. The leaders, affirmed the warm and longstanding relations between Singapore and Timor-Leste. Prime Minister Lee also reaffirmed Singapore's in-principle support for Timor-Leste's ASEAN membership and Singapore's commitment to work constructively with other ASEAN Member States on an objective criteria-based Roadmap for Timor-Leste's ASEAN membership.

# Brazil's Luiz da Silva Inauguration

MINISTER in the Prime Minister's Office, Second Minister for Foreign Affairs, and Second Minister for Education Dr. Maliki Osman visited the Federative Republic of Brazil from 1 to 3 January 2023 to attend the inauguration ceremony of President-elect Luiz Inácio Lula da Silva. Minister Maliki met with newly-appointed Brazilian Foreign Minister Mauro Vieira to discuss ways to strengthen bilateral cooperation between Singapore and Brazil.

Singapore looked forward to the signing of the MERCOSUR-Singapore FTA this year, which will boost trade and investment flows between the two countries. Singapore welcomed further cooperation in agri-trade and environment sustainability, including carbon credits, as well as people-to-people exchanges among our youth.

Singapore welcomed Brazil's goal to strengthen dialogue and cooperation at multilateral fora,

including through its upcoming G20 Presidency in 2024. Minister Maliki shared that as convenor of the Global Governance Group, Singapore stands ready to support Brazil's G20 presidency. Minister Maliki also encouraged Minister Vieira to tap into Brazil's new status as an ASEAN Sectoral Dialogue Partner to strengthen engagement with Southeast Asia.

# 3G on the G20 Summit Outcome

THE Global Governance Group (3G) welcomed the successful and substantive outcome of the Group of Twenty (G20) Summit held in Bali, Indonesia, from 15 to 16 November 2022. The 3G noted that the G20 Summit took place at a time of unparalleled multidimensional crises, including the COVID-19 pandemic and climate change, and that the G20 has witnessed that the war in Ukraine further adversely impacted the global economy. The 3G appreciates the G20's of the G20 in 2023 commitment to uphold in-

ternational law and the multilateral system, which includes defending all principles enshrined in the United Nations (UN) Charter.

In the context of the prevailing food crisis, the 3G welcomed the commitment of the G20 to take urgent actions to save lives, prevent hunger and malnutrition, particularly to address the vulnerabilities of developing countries, and call for an

tion towards sustainable and resilient agriculture, food systems and supply chains. The 3G thus appreciated the G20's support for open, transparent, inclusive, predictable and non-discriminatory, rulesbased agricultural trade based on World Trade Organisation rules

The 3G noted the G20's assessment that they were experiencing volatility in energy prices and markets, as well as shortages and disruptions to energy supply, which have been

compounded by geopolitical challenges. In this context, the 3G appreciated the G2O's commitment to transform and diversify energy systems, and advance energy security and resilience by accelerating clean, sustainable, just, affordable, and inclusive energy transitions.

# **Interview With** Ambassador Zulkifli Baharudin

The Non-Resident Ambassador of the Republic of Singapore to the Republic of Uzbekistan shared with Publisher and Editorin-Chief of IN Diplomacy, Ms Nomita Dhar, his thoughts on the visit of the President Shavkat Mirziyoyev and how Singapore and Uzbekistan can benefit going forward



#### We are meeting on the eve of President Shavkat Mirziyoyev's first State Visit to Singapore. What can we expect from this visit?

A: First and foremost we have a very good and long-standing relationship with Uzbekistan since the country became independent (in 1931). Although Singapore is very far away from Uzbekistan, more people are beginning to take notice of Uzbekistan and the progress the nation has achieved, especially the recent reforms undertaken by President Shavkat.

I think the visit is a very good time for Singaporeans to find out more about what's happening in Uzbekistan and the progress they've made. And the opportunity is not just economic and political but also people-to-people. I think this is the right time for the President to be here as Singaporeans can get closer and get to know more about Uzbekistan.

#### Q: You have been the non-resident ambassador of Uzbekistan since 2011; what has struck you most about Uzbekistan during the many times you have travelled there?

A: I think many are not aware of the independence of Uzbekistan and some might think it is still a part of Russia. We are certainly aware of Russia but are not aware about the many other countries which broke away from it. Certainly after independence, Uzbekistan does stand out especially most recently because of (China's) One Belt One Road initiative and the reforms that the current President has started has caused many to take notice of the country. Uzbekistan is not a young country; it is an old civilisation with a great historic culture and a people who are strong, highly energetic and very ambitious in what they want to achieve for themselves. There is emphasis on tradition and religion and I think these are things that Singaporeans should look at about Uzbekistan. I believe we can learn a lot from Uzbekistan as much as Uzbekistan wants to come here to see what are the things that we can work at together and share with one another's best practices.

#### O: How can Singapore contribute in the development of Uzbekistan?

A: When we talk about relationships, we cannot ignore the fact that the Singapore-Uzbekistan relationship has a tremendous amount of political goodwill. In time that political will gets translated into economic opportunities and improved people-to-people relations. In terms of economic opportunities businesses will find their own way to maximise opportunities.

But as far as country-to-country relations are concerned, as good friends, we have a lot to learn from one another. Singapore being a global city will be able to share our experiences. Uzbekistan wants to plug into an emergent Southeast Asia for which Singapore is a very important hub.

#### Q: How many Singaporean companies are currently operating in **Uzbekistan?**

A: There are not many but the few that are there have made a tremendous impression in the areas of education, agriculture, chemical and oil & gas

Although small I think they have made a tremendous impact. We have certainly been recognized for what we're doing. And I hope, the success of these companies will set an example for other Singaporean companies to follow suit. The companies also owe their success to the host country government which has been very fair in helping them.

#### Q: What are the other areas of collaboration that can be further developed?

A: There are three main areas. First, is political. In the past many years Singapore has undergone digital electronic reforms in terms of instituting e-governance. Governments the world over have been finding ways to use technology to better administer their countries. This is a potential area where the two governments might work together. Singapore is quite ahead in this area.

The second area involves people-to-people ties. Singaporeans are travelling more and to more distant destinations, looking for a bit more educational and bit more epic attractions in terms of experience. I think Uzbekistan's ancient cities of Samarkand, Bukhara and Khiva offer a great experience for anybody, not just Singaporeans. There is a lot for us to learn. This is one way people-to-people ties can be more deeply engaged.

Lastly, in terms of business, Uzbekistan which is an emerging economy with the largest population in the region, is embarking on very strong, disciplined reforms that will lead to the opening up of a host of opportunities in many sectors of the economy.

#### Q: In anticipation of these new opportunities, do you think the Singapore Government should consider opening an embassy in Uzbekistan?

A: That's two different questions! Yes, certainly, I think diplomatically Singapore would want to have an embassy in all the countries with representation. There's no question about it. We might have the financial resources but we just don't have the manpower.

Singapore is unique, really. We have a system of Non-Resident Ambassadors like me who don't work full-time but I can spend my time and resources to do my own work.

Of course, if down the line, we can have the manpower resources with people familiar with the place, speak the language and are prepared to stay there, we will consider it. Sometimes the fact that I'm in Singapore instead of being in Uzbekistan allows me to work more closely with the Uzbekistan Ambassador here. I will not be able to coordinate things as well as I might have if I'm in Uzbekistan!

#### Q: Ambassador, while Singapore companies are being encouraged by Enterprise Singapore to set up shop there would you like to encourage more Uzbek established companies to look at Singapore market as well?

A: Yes, but ultimately businesspeople make their own decisions. We have to be aware that distance is still a bit of an issue. Singapore and Uzbekistan businesses naturally prefer to work in their own respective neighouring regions. Down the line when connectivity improves certainly we can do that. Meantime, Uzbek businesses which are looking towards venturing into the emerging and growing ASEAN market of 600 million people will find Singapore more than happy to encourage, assist, and cooperate with Uzbekistan to find ways to explore markets in this region. Singapore is a small market but the region offers tremendous opportunities.

# Uttar Pradesh-Singapore Ink Agreements



Uttar Pradesh Global Investor Summit

UTTAR Pradesh is the largest state in the union, with over 220 million people. It is aiming to become a USD 1 trillion economy in sync with the central government's target to build a USD 5 trillion national economy in the coming years.

Uttar Pradesh Minister for Jal Shakti and Flood Control Swatantra Dev Singh while on a promotional tour for foreign investments said: "To achieve such targets, the UP government needs to have around USD 50 billion grounded as early as possible." Singh, who led one of the eight delegations sent to over 16 countries by the UP government to promote the UP Global Investors Summit (UPGIS), shared that there was a very encouraging response from his roadshows in Singapore and Sydney.

Representatives of the UP Government also met the representatives of the Singapore Indian Chamber of Commerce and Industries (SICCI) during the roadshow in Singapore. The investors from Singapore were assured of providing land and other facilities

In his welcome note SICCI Chairman, Mr Neil Parekh, said companies are rushing to re-capture global markets after a two-year lull. He discussed the upcoming Uttar Pradesh Global Investor Summit 2023 as an opportune moment to capitalize on the opportunities in the Indian state for Singapore businesses to explore and sign deals with the UP counterparts. Several SICCI members have registered to take part in the global summit.

High Commissioner P Kumaran spoke about the State of Uttar Pradesh and how it has progressed over the years and continues to grow. HE highlighted that with a little over 200 million residents and one of the largest GDPs of the country in recent years the state had established many IT parks for Singaporean IT firms to consider investing in. Other investment sectors include Defence, Aerospace, and Agriculture, he shared.



# World Arabic Language Day Celebration

EVERY year since 2012, the 18th of December has been designated as "World Arabic Language Day." The date falls on the same day that the United Nations General Assembly designated Arabic as the sixth official language of the organization in 1973. The celebration featured a wide range of events and activities in addition to visual content that focused on important and fascinating subjects that highlighted the Kingdom's contribution to the Arabic language. A poem titled "How Beautiful Is My Arabic Language" was also recited in front of the audience. The celebration was attended by a number of government representatives, ambassadors, and heads of diplomatic missions.





# Indonesia-Singapore Agreement on QR Code Payment

PAYMENT connectivity between Indonesia and Singapore will enable individuals and businesses, particularly micro, small, and medium enterprises (MSMEs), to conduct efficient cross-border trade, e-commerce, and other financial transactions.

BI and MAS also agreed to use local currency in bilateral transactions between the two countries, such as trade and direct investment. Business actors can also benefit from this initiative to reduce their exposure to exchange rate risk and costs when conducting bilateral transactions between countries.

The Governor of BI, Perry Warjiyo, on the occasion said, "This initiative is seen as providing more choices for users of cross-border payment transactions and playing an important role in increasing transaction efficiency, promoting the digital economy and financial inclusion, and strengthening macroeconomic stability through



wider use of local currency. Bank Indonesia believes that this initiative marks an important milestone in strengthening bilateral financial cooperation between Singapore and Indonesia."

MAS Managing Director, Ravi Menon, also said that "QRIS-NETS QR code payment connectivity is an important milestone in achieving ASEAN's goal of building payment integration in the region by 2025 and supporting the dynamics of crossborder trade corridors. The MOU in the context of encouraging the use of local currency for bilateral transactions is seen as being able to complement efforts to strengthen connectivity for QRIS-NETS QR code payments through the ease of settlement of bilateral transactions between Singapore and Indonesia in each country's local currency."

## MTI Reports 3.8% GDP Growth in 2022

SINGAPORE'S Ministry of Trade and Industry has announced that based on advanced estimates. the Singapore economy grew by 2.2 percent on a year-on-year basis in the fourth quarter of 2022, moderating from the 4.2 percent growth in the previous quarter. On a quarter-on-quarter seasonally-adjusted basis, the economy expanded by 0.2 percent, extending the 1.1 percent expansion in the third quarter. For the whole of 2022, the economy grew by 3.8 percent, slower than the 7.6 percent growth in 2021. For the full reports visit: www.indiplomacy.com
