### FACETIME in March 2024



During a pivotal two-day working visit to Amman, Jordan, from 16 to 17 March 2024, Singapore's Minister for Foreign Affairs, Dr. Vivian Balakrishnan, engaged in profound discussions with his counterpart, Deputy Prime Minister and Minister of Foreign Affairs and Expatriates Ayman Safadi. This meeting underscored the robust bilateral ties between Singapore and Jordan, with a spotlight on their collaborative humanitarian assistance initiatives in Gaza. The ministers deliberated on enhancing aid channels to Gaza, amidst calls for a humanitarian ceasefire, and reminisced about the fruitful outcomes of His Royal Highness Crown Prince Al Hussein Bin Abdullah II's visit to Singapore earlier in January 2024.




On 18 March 2024, Dr. Vivian Balakrishnan, Singapore's Minister for Foreign Affairs, embarked on a vital working visit to the Palestinian Territories. Meeting with prominent Palestinian leaders, including the PA Prime Minister and the Minister of Foreign Affairs and Expatriates, Minister Balakrishnan voiced Singapore's concern over Gaza's humanitarian crisis and advocated for an immediate ceasefire. He underscored Singapore's support for a two-state solution as a pathway to peace and detailed the nation's humanitarian contributions to Gaza.



From 19 to 20 March 2024, Dr. Vivian Balakrishnan's visit to Israel was marked by key meetings with Israeli leadership, including President Isaac Herzog and Prime Minister Benjamin Netanyahu. Minister Balakrishnan condemned the attacks on 7 October 2023 and called for the protection of civilian lives in Gaza, urging for an immediate ceasefire to allow humanitarian aid. He reaffirmed Singapore's support for a twostate solution and engaged with a broad spectrum of Knesset members to discuss peace, humanitarian efforts, and regional stability. This visit underscored Singapore's commitment to fostering dialogue and understanding amidst the complex geopolitical landscape of the region.



During a constructive visit from 19 to 20 March 2024, Hungary's Minister of Foreign Affairs and Trade, Mr. Péter Szijjártó, commenced his Singapore journey with a working dinner hosted by the Singapore Manufacturing Federation (SMF). Discussions focused on bolstering bilateral trade and investment, highlighting the strong economic ties and the significance of Singapore as a key partner for Hungary in Southeast Asia. The engagements emphasized the mutual interest in further strengthening the robust relationship between the two nations.



Senior Minister Teo Chee Hean's visit to China from 17 to 22 March 2024 facilitated high-level discussions aimed at fortifying Singapore-China ties. Covering strategic regions such as

Sichuan, Zhejiang, and Beijing, Senior Minister Teo engaged with local officials and Singaporean businesses to deepen cooperation and understand economic developments. Key meetings celebrated bilateral milestones and discussed future collaborations in connectivity, security, and social governance, reflecting the dynamic and evolving partnership

between Singapore and China.



The Minister of the International Department of the Communist Party of China, Mr Liu Jianchao, called on Deputy Prime Minister and Minister for Finance Mr Lawrence Wong on 26th March 2024. They reaffirmed the warm and longstanding bilateral relations and cooperation and looked forward to the successful convening of the 20th Joint Council for Bilateral Cooperation (JCBC) meeting in Singapore later this year. They also discussed the importance of an open, rules-based multilateral trading system and ASEAN-China relations for the region.

The President's Annual Diplomatic Dinner Reception (also known as PADR) hosted by the President of the Republic of Singapore, H.E. Tharman Shanmugaratnam and the First Lady Jane Ittogi Shanmugaratnam at Istana Palace was held on the evening of 20th March 2024. The first PADR was held in 1965 and was organised to thank ambassadors for fostering friendly relations with Singapore.

A major highlight in the year's diplomatic calendar, was the welcome of Singapore's President and First Lady to the heads of the diplomatic and consular missions and







representatives of international organisations to Singapore along with Prime Minister Lee Hsien Loong and cabinet ministers, parliamentarians and senior officials of Singapore also attended the PADR.

## 9th Singapore-Australia Annual Leaders' Meeting: Go Green and Digital

Both leaders build on Singapore-Australia Comprehensive Strategic Partnership with launch of A\$20 million grant for collaborative efforts in green sectors and MoU on Green and Digital Shipping Corridor



Prime Ministers Lee Hsien Loong and Anthony Albanese reaffirmed the excellent state of bilateral relations and noted the good progress in bilateral cooperation of the Singapore-Australia CSP

rime Minister Lee Hsien Loong and Australian Prime Minister Anthony Albanese held the 9th Singapore-Australia Annual Leaders' Meeting in Melbourne on 5th March 2024. Following the Meeting the Prime Ministers held a Joint Press Conference where they highlighted the progress made on the Singapore-Australia Comprehensive Strategic Partnership (CSP). The CSP was established in 2015 and that covers broadly both countries' relationship in Economics and Trade, Defence and Foreign Affairs, Science and Innovation, People-to-People, Digital Economy and Green Economy.

The leaders issued a Joint Statement that outlined the key outcomes that were agreed on at the 9th Meeting:

• They noted the good progress in implementing the Singapore-Australia Green Economy Agreement (SAGEA) since it was signed in October 2022, including the announcement of initial recipients of the A\$20 million **Go-Green Co-Innovation Programme Grant** which supports Singapore and Australian enterprises in collaborative efforts to innovate products and services in green sectors.

During his visit to Australia Prime Minister Lee Hsien Loong also attended the ASEAN-Australia Special Summit that was held from the 4th to 6th March 2024. The Summit commemorated the Golden Jubilee of ASEAN-Australia Dialogue Relations. Australia is ASEAN's oldest Dialogue Partner. During the Summit, Australian PM Anthony Albanese and ASEAN Leaders announced a US\$500 million package of new and expanded initiatives to commemorate the 50th Anniversary of ASEAN-Australia Dialogue Relations.  They welcomed the signing of the MoU formalising the Green and Digital Shipping Corridor (GDSC), which will spearhead the shared goal and collaboration to accelerate maritime decarbonisation and digitalisation. They encouraged the Maritime and Port Authority of Singapore (MPA) and Australia's Department of Infrastructure, Transport, Regional Development, Communications and the Arts to continue engagement with Australian state and territory governments to develop work plans to implement the MOU.

• The Leaders welcomed the **Ten Principles to Guide the Development of Cross Border Electricity Trade** that were jointly developed by Australia and Singapore to

facilitate cross border trade in electricity. This would form the basis for the subsequent development of standards and norms in deepening regional energy connectivity.

• The Leaders welcomed Australia's commitment to enhance business connections, trade and investment into Southeast Asia, including through initiatives implementing **Invested: Australia's Southeast Asia Economic Strategy to 2040.** The Leaders tasked officials to further enhance and facilitate investment opportunities in Australia and Singapore, as well as expand synergies and cooperation in the region.

• As the CSP marks its 10th anniversary in 2025, the Leaders agreed that cooperation under the next phase of the CSP should be ambitious, future-oriented and pathfinding, and should comprise concrete initiatives in areas such as supply chain resilience, food security, climate change and green economy, energy security and clean technology, defence, health, education, trade and investment, connectivity, creative industries, digital economy, cyber and critical technologies, homeland safety and security, as well as science and innovation.

## Dr. S. Jaishankar's **Diplomatic Visit to Singapore**

In March 2024, Dr. S. Jaishankar, the External Affairs Minister of India, conducted a visit to Singapore from the 23rd to the 25th. This trip was aimed at reinforcing the longstanding relationship between India and Singapore, focusing on enhancing bilateral ties and exploring avenues for future cooperation.

xternal Affairs Minister of the Republic of India, Dr. S. Jaishankar, embarked on a significant visit to Singapore from March 23 to 25, 2024, to reinforce the bilateral relations between India and Singapore. Each meeting with Singaporean officials underscored the multifaceted partnership between the two countries.

In his meeting with Singapore's Prime Minister, Mr. Lee Hsien Loong, they discussed the broad spectrum of India-Singapore relations, including trade, investment, and defense. They emphasized the importance of strengthening economic ties and explored new initiatives to enhance collaboration in technology and innovation.

Dr. Jaishankar also met with Mr. Lawrence Wong, the Deputy Prime Minister and Minister for Finance. Their discussion focused on economic collaboration and investment opportunities, highlighting the potential for growth in bilateral trade and investment.

Another key meeting was with Mr. Teo Chee Hean, Senior Minister and Coordinating Minister for National Security. Their conversation delved into security cooperation and regional stability, addressing shared concerns over maintaining peace and security in the Indo-Pacific region.

His engagement with Dr. Vivian Balakrishnan, Minister for Foreign Affairs, was pivotal in discussing bilateral and multilateral diplomatic initiatives. They reviewed ongoing cooperation in international forums and sought ways to intensify collaboration on global issues.



The meeting with with Mr. Gan Kim Yong, Minister for Trade and Industry, focused on enhancing trade relations and economic cooperation. The dialogue centered on identifying new opportunities for collaboration in sectors such as technology, e-commerce, and renewable energy.

At the Institute of South Asian Studies (ISAS) - National University of Singapore (NUS), Distinguished Lecture event titled #WhyBharatMatters, External Affairs Minister of India, Dr. S. Jaishankar, shared his insights on India's pivotal role in global diplomacy and economy. He emphasized India's contributions in shaping a balanced world order and its strategic partnerships that underscore its growing influence. Highlighting the nation's historical and cultural legacy, Dr. Jaishankar illustrated why understanding India's trajectory is crucial in the contemporary global landscape. His lecture reinforced the significance of India's position and responsibilities on the world stage.

## **Bridging Cultures and Opportunities** with Armenia's Ambassador to Singapore

IN Diplomacy engaged with the Ambassador of Armenia to Singapore, H.E. Mr. Serob Bejanyan, to discuss the evolving landscape of Armenia's diplomatic ties and economic relations with Singapore. Highlighting the journey since diplomatic relations were established in 1992, Ambassador Bejanyan shares insights into the challenges and opportunities ahead, emphasizing the potential for mutual growth and collaboration



When were diplomatic relations between Singapore and Armenia established? Diplomatic relations between the Republic of Armenia and the Republic of Singapore were established on July 1st, 1992.

#### Given that the embassy is currently based in Jakarta, how do you effectively engage with Singapore and foster bilateral relations?

Yes, indeed, the embassy is located in Jakarta and covers not only Indonesia, but also Singapore and Malaysia. And, of course, this somehow creates difficulties. However, the embassy endeavors to engage with relevant Singaporean authorities in both the public and private sectors to enhance political and economic relations between the two countries for the benefit of our people.

Unfortunately, the absence of an accredited Singapore embassy in Armenia is another obstacle to the effectiveness of bilateral relations.

#### Can you provide an overview of the investment and trade ties between Armenia and Singapore?

Armenia and Singapore have been working to strengthen their economic ties, albeit with relatively modest trade and investment volumes. The trade relationship between the two countries certainly has a room for growth.

Armenia offers potential investment opportunities in areas such as information technology, renewable energy, agriculture, and tourism. The Singaporean government and businesses may find Armenia attractive due to its skilled workforce, competitive costs, and strategic location as a gateway to regional markets.

Singapore can serve as a valuable partner for Armenia in accessing markets in Asia, while

#### between the two nations.

Armenia provides Singapore with opportunities to tap into the Eurasian Economic Union and the broader Caucasus region.

Surely, there is real potential for deeper cooperation and mutual benefits in the future. In recent years, aluminum products, ores and mines, watches, natural juices, and wine have been exported from Armenia to Singapore. Inversely, pharmaceutical products, electrical, optical, photographic equipment, and machinery are imported from Singapore to Armenia.

#### What advice do you have for Singaporeans looking to visit Armenia for both business and pleasure? Overall, visiting Armenia for both business

Overall, visiting Armenia for both business and pleasure can be a rewarding experience, offering a blend of cultural enrichment, business opportunities, and natural beauty. By planning ahead and embracing the local culture, you can make the most of your trip to our fascinating country.

For business purposes, we recommend looking through diverse collection of publications covering Armenia's economic sectors. Once business interests in Armenia are specified, Enterprise Armenia, the national investment promotion agency of Armenia, is ready to assist business partners by providing a comprehensive range of services throughout the entire investment process, completely free of charges or fees, including providing information on Armenia's business climate, investment opportunities, and relevant legislation, arranging relevant meetings with actors from the public and private sectors.

I would also like to note that since March 2018, Singaporean citizens are exempt from the need to obtain a visa to visit Armenia. This facilitates visiting and exploring the rich history and culture of Armenia.

#### How has the Armenian economy been performing recently?

For years, Armenia has been registering constant economic growth of 6-7 percent annually. The year 2020, however, was a year of a global crisis, and Armenia's economy has faced various challenges, including the COVID-19 pandemic and the war in the Armenian-populated Nagorno-Karabakh.

These factors have had a significant impact on economic performance. But Armenia's economy decrease was not so dramatic, and in 2021 we recovered the growth rate to 5.7%. This growth trend is constant, and even stronger in 2022 with 12.6% growth. Currently, the main contributors to the GDP are agriculture, industry and construction, as well as service - with booming tourism and IT sectors.

International organizations such as the OECD and The Heritage Foundation consistently rate Armenia highly for its economic freedom.

Armenia also has a strong and stable financial and fiscal system, which is confirmed by the country's positions in international indices.

### What is Armenia's investment policy and what incentives are offered to foreign investors?

Thanks to the liberal policies adopted by the government, Armenia's FDI legislation is one of the most flexible and business-oriented ones among emerging markets, so:

- Foreign nationals doing business in Armenia have the right to a 100% ownership of the resident legal entities in Armenia;

- The legislation safeguards investors against discriminatory policies. Investors, regardless of their citizenship receive equal treatment, unless a more favorable regime is provided by a respective treaty;

- Investors have virtually unrestricted access to any sector and location throughout the country;

- Companies owned by foreign nationals have the right to purchase land. Foreign citizens can have long-term lease contracts.

# **Armenia** A Promising Destination for Global Investors

Armenia, nestled in the South Caucasus region, has long been celebrated for its rich cultural heritage, ancient history, and breathtaking landscapes. However, in recent years, this nation has been making headlines for a different reason — its remarkable economic growth, increasing attractiveness for investors and emerging regional hub for tech and innovations

www.ith a blend of ancient traditions and modern aspirations, today Armenia is positioning itself as a rising destination in the global investment landscape.

For years, Armenia has demonstrated consistent GDP growth rates, typically hovering between 6-7%. Despite the challenges posed by the global health crisis in 2020, Armenia managed to weather the storm relatively well, with a slight economic decrease. However, the resilience of its economy was truly showcased in 2022 when it bounced back with a staggering 12.6% GDP growth rate, being rated as a 4th fastest-growing economy in the world according to the IMF. Building on this momentum, projections for 2023 suggest a continued GDP growth trajectory, with estimates reaching around 9%.

Simultaneously, the country has made significant strides in improving its macroeconomic solidity and business environment in recent years. Diversification of the economy and trade destinations, green transition, as well as, strengthening of the private sector have been key priorities. Structural reforms aimed at promoting fiscal sustainability and fostering a favorable investment climate have been implemented, resulting in increased investor confidence and a conducive business environment. Liberal Investment Environment Armenia currently maintains one of the

most liberal investment environments among emerging market countries. The government's commitment to an "open door" policy ensures that there are virtually no restrictions on investment activities, with foreign investors enjoying equal treatment as the locals under the national legislation. Foreign investments in Armenia are fully protected, investors have a number of

guarantees and advantages. According to the RA Law "On Foreign Investments", foreign investors in Armenia are given a national regime, that is, they operate in accordance with general legislation (like local companies), which ensures nondiscriminatory treatment towards them.

Foreign investors are also given the most favourable treatment, as well as a number of privileges. This openness and transparency are coupled with low business costs, efficient and businessfriendly tax environment and last but not the least availability of skilled and educated human capital. Moreover, the government is committed to further improving the business climate through a range of tax incentives and comprehensive state support programs.

For example, the Armenian Government provides up to a 20% return on capital investments for securing the infrastructure needs of the project, reimburses up to 70% of the monthly wages for newly hired highly qualified foreign specialists, offers up to a 35% reimbursement of capital investments for producing economically complex products, and implements other support programs, showcasing Armenia's proactive stance in creating an environment conducive to investment and economic growth.

Most of the state support programs are directed towards the increase of economic productivity, introduction of innovations, further diversification of industries and sophistication of production value chains. 
one of Armenia's fastest-growing industries, boasting a consistent annual growth rate of 20% and comprising around 5% of the local GDP. Not surprisingly, reputable independent organizations name Armenia a technological hub of the region. This is due to the presence of a large number of globally recognised tech giants, vibrant tech ecosystem, innovative educational initiatives, and active technology transfer. Furthermore, Armenia has become a birthplace for several tech unicorns, underscoring its prowess in the global tech landscape.

#### Strategic Advantages

Beyond its favourable business environment, Armenia boasts several strategic advantages, including its role as a gateway to major markets. As a member of the Eurasian Economic Union (EAEU), Armenia has access to a vast consumer market comprising 184 million people. The Union has free trade agreements with Singapore, Vietnam, Serbia and Iran. Armenia also maintains free trade agreements with CIS countries and Georgia. Furthermore, GSP regimes with key trading partners such as the United States, Japan, Canada, Switzerland, and Norway provide preferential access for Armenian products, enhancing its competitiveness on the global stage. Hence, Armenian producers benefit from unique access to a consumer market of over 1 billion people with 0% or reduced customs duties.

The High Commissioner was also interviewed by *IN Diplomacy* magazine's Editor-in-Chief, Ms Nomita Dhar, on International Women's Day. She was asked to share Pakistan's progress in the area of women empowerment and her take on the state of bilateral relations with Singapore. "There's been a transformative change in Pakistani society. I joined the foreign service in 1994 coming from a very conservative part of Pakistan where many girls at that time didn't go to university. Me and my two sisters were the first women to go to uni and I did my masters in political science during a time when this was very unusual for women to undertake tertiary education in my village. I then decided to sit in for the competitive civil service examination and I didn't stop there. I passed and chose the diplomatic service which was a very rebellious step as going, studying, working and living abroad for a single woman was also not a common thing - almost unthinkable.

In the past 30 years though I have seen a significant change take place in Pakistan. Today there are more Pakistani women studying in universities than men. Women are also doing very well in the entry exams of engineering universities and medical colleges. Now there are so many women in careers like the police force, in the administration of cities and even as fighter pilots! Remember Pakistan was the first Muslim country to have a woman prime minister; a woman parliamentary speaker, woman governor, foreign minister and also first Principal Secretary to the Prime Minister."
