


Singapore-Portugal Innovation Alliance Launched in January 2024

On 5th January 2024, Singapore's Minister for Foreign Affairs, Dr Vivian Balakrishnan, and the Minister of Foreign Affairs of Portugal, João Gomes Cravinho, held a significant meeting to reaffirm the strong bilateral ties between the two nations. A key outcome of the visit was the inauguration of the Singapore-Portugal Innovation Alliance (SPIA) by both Ministers to boost collaboration among startups and tech companies, fostering business networks and facilitating market entries. Discussions also included its capital Lisbon's potential as a startup hub and agreeing to enhance exchanges in innovation,

housing, and public service.

The World's Most 'Powerful' Passports

Singapore and Japan have dominated 1st place on the index (which ranks all the world's passports according to the number of destinations their holders can access without a prior visa) for the past five years. This year they are joined by four EU member states — France, Germany, Italy, and Spain — to be the most "powerful" passports in the world, with their citizens able to visit 194 destinations out of 227 around the globe visa-free.
