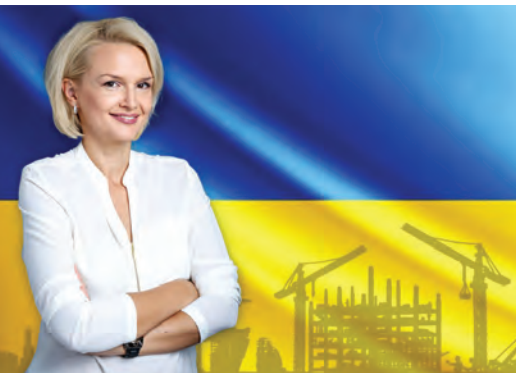


## Philippine Embassy in Singapore Commemorates 126th Philippine Independence Anniversary
